This Supplement (the **Supplement**) constitutes a supplementary prospectus for the purposes of Article 23 of Regulation (EU) 2017/1129 (the **Prospectus Regulation**) and is prepared in connection with the Programme for Continuous Issuance of Covered Bonds (the **Programme**) established by AB Sveriges Säkerställda Obligationer (publ) (The Swedish Covered Bond Corporation) (the **Issuer**). This Supplement is supplemental to, and should be read in conjunction with, the prospectus relating to the Programme dated 5 April 2024, with registration number 24-8553 that was approved by the Swedish Financial Supervisory Authority (Sw. *Finansinspektionen*) (the **SFSA**) the same date, which comprises a base prospectus for the purposes of the Prospectus Regulation (the **Base Prospectus**). Terms defined in the Base Prospectus have the same meaning when used in this Supplement, and reference is made to the information in the Base Prospectus and to the documents incorporated by reference therein. Any decision to invest in the Covered Bonds must be based on the Supplement and the Base Prospectus taken as a whole and any documents incorporated by reference.

This Supplement has been approved and registered by the SFSA as competent authority under the Prospectus Regulation. The SFSA only approves this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. The SFSA's approval should not be considered as an endorsement of the Issuer or of the quality of the Covered Bonds that are subject to this Supplement. Investors should make their own assessment as to the suitability of investing in the Covered Bonds.

### **Purpose of this Supplement**

The purpose of this Supplement is (a) to incorporate by reference the unaudited financial statements of the Issuer for the period 1 January - 30 June 2024, including the limited review report thereon (the **Interim Results**) and (b) to include new statements on trend information and significant changes.

### **Interim Results**

On 17 July 2024, the Issuer published its interim report for the period 1 January - 30 June 2024, including the Interim Results (the **Interim Report**). A copy of the Interim Report has been filed with the SFSA and, by virtue of this Supplement, the Interim Results are incorporated in, and form part of, the Base Prospectus.

### **Information incorporated by reference and Documents available**

The first sentence of the first paragraph under the heading "Information incorporated by reference" on page 52 of the Base Prospectus shall be deleted and replaced with the following:

This Prospectus should be read and construed together with the audited annual financial statements of SCBC for the financial years 2022 and 2023, together in each case with the audit report thereon, and the unaudited Interim Results.

The following item shall be added to the list of financial statements under the heading "Information incorporated by reference" on page 52 of the Base Prospectus:

- SCBC's Interim Report, where reference is made to the Interim Results on pages 9 to (including) 26, the limited review report from the auditor on page 28 and alternative performance measures on page 27.

The last paragraph under the heading "Information incorporated by reference" on page 52 of the Base Prospectus shall be deleted and replaced with the following:

With the exception of SCBC's financial statements for 2023 and 2024 and SCBC's Interim Report, no information in this Prospectus has been audited or reviewed by SCBC's auditor.

The following item shall be added to the list of documents under the heading "Documents available" on page 52 of the Base Prospectus:

- SCBC's Interim Report.

### **Trend information and significant change**

The second sentence under the paragraph headed “Trend information” on page 51 of the Base Prospectus shall be deleted and replaced with the following:

#### **Trend information**

There has been no significant change in the financial performance of SCBC since 30 June 2024, being the end of the last financial period for which financial information has been published to the date of this Prospectus.

The paragraph headed “Significant Change” on page 51 of the Base Prospectus shall be deleted and replaced with the following:

#### **Significant Change**

There has been no significant change in the financial position of SCBC since 30 June 2024, being the end of the last financial period for which financial information has been published to the date of this Prospectus.

### **General Information**

To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into the Base Prospectus by this Supplement and (b) any other statement in, or incorporated by reference into, the Base Prospectus, the statements in (a) above will prevail.

To the extent that any document or information incorporated by reference itself incorporates any information by reference, either expressly or impliedly, such information will not form part of this Supplement for the purposes of the Prospectus Regulation, except where such information or documents are stated within this Supplement as specifically being incorporated by reference or where this Supplement is specifically defined as including such information. Save as disclosed in this Supplement, there has been no other significant new factor, material mistake or material inaccuracy relating to information included in the Base Prospectus since the publication of the Base Prospectus.
